SECTION I - Registration

1. Membership in the O.M.A.H.A., Inc. is open to anyone. Membership may be applied for by acquiring, completing, and filing an application form with the membership secretary. When the application is accepted and appropriate fees are paid by check, PayPal, or credit card to the membership secretary, each member will receive a membership number for the current year they join. The O.M.A.H.A., Inc. rule book is available for download at OMAHAEquine.com. The address of membership secretary may be found on page 3.
2. A rider must be a current members of O.M.A.H.A., Inc. in good financial standing to be eligible to receive points toward annual awards. Membership is non-transferable.
3. The O.M.A.H.A., Inc. membership year commences on January 1 of each year. Dues become payable on that date in which memberships expire the following December 31. Anyone joining at any time during the membership year must pay the entire annual dues fees.
4. Applicants may join at a show to have points recorded for that same show.
5. The Membership/Point Secretary of the association must be notified in writing of any change to a horse's name and a name change fee of five dollars must be paid.

SECTION II - Horse Show Requests

1. All organizations/individuals requesting an O.M.A.H.A., Inc. Horse Show shall submit an O.M.A.H.A. Horse Show Request Form to the President by November 30 for a show in the following calendar year. O.M.A.H.A. reserves the right to approve show management and location. Show Request Forms may be obtained by contacting the Recording/Corresponding Secretary (see page 3 for address) or on the O.M.A.H.A. website.
2. The O.M.A.H.A., Inc. Board Officers reserve the right to consider additional shows during the year, subject to the same rules as all other show requests.
3. The horse show recognition fee is \$75 per horse show.

Notice to Host Barns: Management shall administer the Karla Woodard Memorial Horsemanship Exam. Tasks shall include: Collect \$5 per entry after confirming membership is current; Offer the exam on both Saturday and Sunday of the show; Grade the exams to determine the top three scorers for each day; Provide ribbons for the top three scorers for both days; Remit the funds collected to the O.M.A.H.A., Inc.

The O.M.A.H.A., Inc will match all funds collected or donation to a local charity. The charity will be named at the Awards Brunch.

SECTION III - Entry Fees

1. The entry fees authorized per O.M.A.H.A. class at each show are as follows:

Karla Woodard Memorial written exam	\$5
All other classes	\$15
Facility/Office Fee	\$15
Stall fee	\$35 minimum
Non-showing horse schooling fee	\$35
Service Charge on a Returned Check	\$30

Please check your show bill.

2. No horse may enter the ring until all fees are paid or secured by a signed blank check at the entry booth. The rider/owners must be in good standing with O.M.A.H.A., Inc.
3. If a person makes payment which is non-negotiable to O.M.A.H.A., Inc. or to a member show, that person will not receive any points from the date of check until settlement is made both for said indebtedness owing to the show or O.M.A.H.A., Inc. and for said service charges or fines. There will be a \$30 service charge for each returned (non-negotiable) check given to O.M.A.H.A., Inc.
4. There will be a service charge for each returned (non-negotiable) check given to show management.
5. Emailing lists may be obtained upon Board approval. **Unauthorized use is prohibited.**

SECTION IV - Conduct of Shows

ALL SHOWS SHOULD ENCOURAGE SAFE, SMART RIDING.

1. Any person showing in O.M.A.H.A., Inc. shows should be familiar with its rules and regulations.
2. Riders in equitation classes are only allowed one entry per class.
3. Only O.M.A.H.A., Inc. classes of those shows recognized by the O.M.A.H.A. will count toward year end awards.
4. The heights of the fences as listed on the show bills are at no time to exceed the stated amount – that is to say a 2' class means the jumps are not to exceed 2'.
5. All O.M.A.H.A., Inc. shows must run the mandatory core classes. They may run additional classes, which may be selected in any combination from the non-core classes or from any type of unrecognized classes.
6. Classes recognized by O.M.A.H.A., Inc. must give awards through sixth place. It is also advisable to list a reserve for each class.
7. Each member show may give additional awards at their shows such as championships, reserve championships or prizes. When championships and reserve championships are awarded, the points will be as follows: 1st- 10, 2nd-6, 3rd-4, 4th-2, 5th-1, 6th-1/2.
 - a. Championships given at member shows will be determined by totaling all the points earned within the specific division. The highest point accumulation receives the championship and so forth. In case of a tie, the entrant with the most points in the over fence classes will be judged higher. In the event of Hunter division ties, the horse with the most points over fences will be adjusted the higher. In the event of jumper division ties, the horse with the fastest time will be adjusted the higher.
8. All O.M.A.H.A., Inc. shows must allow schooling over the Hunter and Equitation show fences at announced times prior to the show or during the show. This information must be included in the show bill.
 - a. Schooling over fences prior to the Jumper division classes and or walking the courses by the riders prior to these classes is at the discretion of the show management. The schooling policy must be stated in the show bill.
9. **O.M.A.H.A., Inc. is a United States Hunter Jumper association Affiliate, however, O.M.A.H.A., Inc. rules will prevail in case of conflict, United States Equestrian Federation rules may be used as a guideline.**

10. Cruelty to or abuse of a horse by any persons at any O.M.A.H.A., Inc. show is forbidden and renders the offenders subject to penalty. The show management may bar the violators from further participation for the remainder of the show. The horse show management shall reserve the right to refuse an entry or to return an entry fee.
11. All O.M.A.H.A., Inc. shows must provide on the show grounds: speaker system, restrooms, parking and schooling areas.
12. O.M.A.H.A., Inc. shows failing to follow the rules of O.M.A.H.A., Inc. will be subject to disciplinary action and or a minimum \$50 fine by the board, as well as jeopardizing the chances of holding future O.M.A.H.A., Inc. recognized shows.
13. Shows are encouraged to use the “two minute rule.” This rule permits management to disqualify an exhibitor from the class who fails to report to the in-gate within two minutes of the first call for that exhibitor.
14. The management may choose to open more than one class at a time. Rotating riders through multiple classes is acceptable. A rider has the option to leave the ring and complete rounds in the rotation fashion, or remain in the ring and complete consecutive rounds in the back to back fashion.
15. Order of go in Hunter, Equitation, and Jumper classes is at the discretion of the horse show management. It is advisable to have a notice posted so all riders understand how the show is handling order of go.
16. All O.M.A.H.A., Inc. shows should list on their show bill their regulations governing the presence of pets.

SECTION V - Attire and Equipment

1. Protective headgear is **required** at all times when mounted anywhere on the showgrounds. All competitors must wear protective headgear, with harness secured, that passes or surpasses current American Society for Testing Materials (ATMS) Standards, certified by the Safety Equipment Institute (SEI). There are many varieties of headgear that are recommended by various organizations. It is the responsibility of adult riders and parents/legal guardians of children to examine the various styles/designs available and make an informed selection of their protective headgear.
2. Each rider must use their correct number with the correct horse. It is the responsibility of the rider to make sure the proper number is being clearly displayed. Riders showing with incorrect or multiple numbers visible will not be judged and they will not receive year-end award points.
3. In Hunter and Equitation classes, clothing should be neat, clean, and conservative in color. When possible, entrants are encouraged to show in proper riding attire: boots, breeches, collared shirt, and riding coat in addition to the helmet. Modifications may be made due to weather.
4. In the Jumper classes, clothing should be neat and clean. Conservative colors are optional. When possible entrants are encouraged to show in proper riding attire: boots, breeches and collared shirt, in addition to the helmet. Modifications may be made due to weather.
5. Hunter equipment: Jumper saddles (astride or side saddle) and English bridles are necessary for showing. Standing Martingales are optional in classes over fences but are not permitted in equitation on the flat or in under saddle classes. A judge may penalize for non-conventional types of equipment such as: saddles, bridles, bits, nosebands and martingales.
6. Jumper equipment: Jumping saddles (astride or side saddle) and English bridles or hackamores are necessary for showing. Martingales are optional.
7. Hair should be neat and worn so the rider's number is visible at all times.
8. Horses should be clean and neat. Braiding is optional.
9. Use of boots and bandages on a horse is prohibited in all Hunter divisions. Boots and/or protective leg wraps are allowed in all Jumper division classes and Equitation classes. Exceptions may be made at the discretion of the show management (i.e. during inclement weather, poor footing, and injuries on a horse). The show manager should inform the judge when exceptions have been allowed.

SECTION VI - Core Divisions and Classes

Any horse/rider combination may only compete in the Introduction Equitation, Next Step Equitation and Next Step Hunter Divisions and/or Classes a maximum of two years.

O.M.A.H.A., Inc. recognizes that jump heights may vary slightly.

The child rider is defined as a person age 17 or younger on December 1 of the previous year.

Classes must have a minimum of three riders for points to be recorded.

Show Management may combine classes of similar heights.

Core classes:

All O.M.A.H.A., Inc. shows must hold all Core Divisions and Classes as listed below. Management may add additional classes of their choosing.

HORSEMANSHIP CLASS

The Karla Woodard Memorial Horsemanship Exam is a written exam open to all members in good standing with the O.M.A.H.A., Inc.

Exams will be created by the O.M.A.H.A., Inc with questions taken from information provided in the United States Hunter Jumper Association's Horsemanship Quiz Challenge Study Guide. Bonus questions may be formulated from topics covered at the O.M.A.H.A., Inc annual clinic.

HUNTER DIVISION

HUNTER CLASSES

1. Next Step Crossrail Hunter- Crossrails 18" and Next Step Hunter- verticals 18": Open to horses and ponies ridden by beginning riders, regardless of age. This division is NOT designed for schooling green horses. It is a division of classes designed for teaching beginner riders (any age) and introducing them to showing. Trotting on course will not be penalized. In under saddle classes, the horses will be asked to walk, trot, and canter. Riders in this division may not enter any classes in any division requiring them to jump higher than 2'
 - (a) Next Step Hunter over fences 18" Crossrails
 - (b) Next Step Hunter over fences 18" Crossrails
 - (c) Next Step Hunter over fences 18" Verticals
 - (d) Next Step Hunter over fences 18" Verticals
 - (e) Next Step Hunter under saddle

2. Diamond (formerly known as Adult Masters) Hunter 18" or 2': Open to horses and ponies ridden by adult amateurs. Riders may choose their fences' height. Fences are to be verticals.
 - a. Adult Masters Hunter over fences 18" or 2'
 - b. Adult Masters Hunter over fences 18" or 2'
 - c. Adult Masters Hunter under saddle
3. Schooling Hunter 2 foot: Open to all horses and ponies. Open to riders of any age regardless of status.
 - a. Schooling Hunter over fences 2'
 - b. Schooling Hunter over fences 2'
 - c. Schooling Hunter under saddle
4. Child Hunter 2': Open to horses and ponies ridden by a child rider.
 - a. Child Hunter over fences 2'
 - b. Child Hunter over fences 2'
 - c. Child Hunter under saddle
5. Schooling Hunter 2'3": Open to all horses and ponies. Open to riders of any age regardless of status.
 - (a) Schooling Hunter over fences 2'3"
 - (b) Schooling Hunter over fences 2'3"
 - (c) Schooling Hunter under saddle
6. Child/Adult Hunter 2'3": Open to horses and ponies ridden by adult amateur or child riders of any age.
 - (a) Child/ Adult Hunter over fences 2'3"
 - (b) Child/ Adult Hunter over fences 2'3"
 - (c) Child/ Adult Hunter under saddle
7. Schooling Hunter 2'6": Open to all horses and ponies. Open to riders of any age regardless of status.
 - (a) Schooling Hunter over fences 2'6"
 - (b) Schooling Hunter over fences 2'6"
 - (c) Schooling Hunter under saddle
8. Low Child/Adult Hunter 2'6": Open to horses and ponies ridden by adult amateur or child riders of any age.
 - (a) Low Child/ Adult Hunter over fences 2'6"
 - (b) Low Child/ Adult Hunter over fences 2'6"
 - (c) Low Child/ Adult Hunter under saddle
9. Schooling Hunter 2'9": Open to all horses and ponies. Open to riders of any age regardless of status.
 - a. Schooling Hunter over fences 2'9"
 - b. Schooling Hunter over fences 2'9"
 - c. Schooling Hunter under saddle

10. Child/ Adult Hunter 2'9": Open to horses and ponies ridden by adult amateur or child riders of any age.
 - (a) Child/ Adult Hunter over fences 2'9"
 - (b) Child/Adult Hunter over fences 2'9"
 - (c) Child/ Adult Hunter under saddle

11. Schooling Hunter 3': Open to all horses and ponies. Open to riders of any age regardless of status.
 - a. Schooling Hunter over fences 3'
 - b. Schooling Hunter over fences 3'
 - c. Schooling Hunter under saddle

12. Child/ Adult Hunter 3': Open to horses and ponies ridden by adult amateur or child riders of any age.
 - (a) Child/ Adult Hunter over fences 3'
 - (b) Child/ Adult Hunter over fences 3'
 - (c) Child/ Adult Hunter under saddle

EQUITATION CLASSES

- (1) Introduction Equitation- Groundpoles and Introduction Equitation- Micro Xs: Open to beginner riders, regardless of age. Consistent trotting of the course will not be penalized. The riders in this division may not enter any O.M.A.H.A. class in any division requiring them to jump higher than 18". It is a division designed for teaching beginner riders (any age) and introducing them to showing. It is not designed for schooling green horses.
 - (a) Introduction Equitation over groundpoles
 - (b) Introduction Equitation over groundpoles
 - (c) Introduction Equitation over fences, Micro Xs
 - (d) Introduction Equitation over fences, Micro Xs
 - (e) Introduction Equitation on the flat: walk/ trot only
 - (f) Introduction Equitation in the flat: walk/ trot/ canter

- (2) Next Step Equitation- Crossrails 18" and Next Step Equitation- Verticals 18" 2: Open to adult amateur or child riders of any age that have not shown at the 2'3" level and above at any show, O.M.A.H.A. or otherwise.
 - (a) Next Step Equitation over fences, Crossrails 18"
 - (b) Next Step Equitation over fences, Crossrails 18"
 - (c) Next Step Equitation over fences, Verticals 18"
 - (d) Next Step Equitation over fences, Verticals 18"
 - (e) Next Step Equitation on the flat

- (3) Diamond (formerly known as Adult Masters) Equitation 18" or 2': Open to adult amateur riders. Riders may choose their fences height. Fences are to be verticals.
 - (a) Adult Masters Equitation over fences 18" or 2'
 - (b) Adult Masters Equitation over fences 18" or 2'
 - (c) Adult Masters Equitation on the flat

- (4) Child Equitation 2': Open to child riders that have not shown at the 2'9" level and above at any show, O.M.A.H.A. or otherwise.
 - (a) Child Equitation over fences
 - (b) Child Equitation over fences
 - (c) Child Equitation on the flat
- (5) Child/ Adult Equitation 2'3": Open to adult amateur or child riders of any age that have not shown at the 3' level and above at any show, O.M.A.H.A. or otherwise.
 - (a) Child/ Adult Equitation over fences 2'3"
 - (b) Child/ Adult Equitation over fences 2'3"
 - (c) Child/ Adult Equitation on the flat
- (6) Modified Child/ Adult Equitation 2'6": Open to adult amateur or child riders of any age that have not shown at the 3'3" level and above at any show, O.M.A.H.A. or otherwise.
 - (a) Modified Child/ Adult Equitation over fences 2'6"
 - (b) Modified Child/Adult Equitation over fences 2'6"
 - (c) Modified Child/Adult Equitation on the flat
- (7) Advanced Equitation 2'9": Open to adult amateur and child riders of any age that have not shown at the 3'6" level and above at any show, O.M.A.H.A. or otherwise.
 - (a) Advanced Equitation over fences 3'
 - (b) Advanced Equitation over fences 3'
 - (c) Advanced Equitation on the flat
- (8) O.M.A.H.A./ INHJA Maiden Medal 2'3": Open to adult amateur and child riders of any age. Riders may not enter Mini Medal or Medal class at the same show. Rider must be an Iowa Nebraska Hunter Jumper Association member for points to be recorded for INHJA year end prizes and recognition. Application for INHJA membership may be made at the show. Riders will first be required to show over a course of not less than eight (8) obstacles of which six (6) must be set at the maximum 2'3". The course must include one change of direction.
- (9) O.M.A.H.A./INHJA Mini Medal 2'6": Open to adult amateur and child riders of any age. Riders may not enter Maiden Medal or Medal class at the same show. Rider must be an Iowa Nebraska Hunter Jumper Association member for points to be recorded for INHJA year end prizes and recognition. Application for INHJA membership may be made at the show. Riders will first be required to show over a course of not less than eight (8) obstacles of which six (6) must be set at the maximum 2'6". The course must include one change of direction. The judge may invite select riders from the over fences section to show back in a flat section. In the flat section, riders shall be shown as a group at the walk, trot, and canter in both directions of the ring. No martingales will be allowed in the flat section. The judge may request further testing items 1-9 from the list below.

(10)O.M.A.H.A./ INHJA Medal 3': Open to adult amateur and child riders of any age. Riders may not enter Maiden Medal or Mini Medal class at the same show. Rider must be an Iowa Nebraska Hunter Jumper Association member for points to be recorded for INHJA year end prizes and recognition. Application for INHJA membership may be made at the show. Riders will first be required to show over a course of not less than eight (8) obstacles of which six (6) must be set at the maximum 3'. The course must include one change of direction (change of lead) and one combination including an oxer. The judge may invite select riders from the over fences section to show back in a flat section. In the flat section, riders shall be shown as a group at the walk, trot, and canter in both directions of the ring. No martingales will be allowed in the flat section. The judge may request further testing items 1-19 from the list below.

Additional testing on the flat may include (tests selected from the United States Equestrian Federation Rules Section EQ113)

1. Work collectively or individually at a walk, rising/posting trot, and/or sitting trot, and/or canter.
2. Downward Transition Test: a) Walk (4-5 steps) b) Halt (4-6 seconds) c) Halt and Back (3-5 steps). When riders working collectively are asked to halt and then back, they should walk forward a few steps and halt again after backing and then proceed with any further instructions from the judge.
3. Intentionally blank.
4. Working either collectively or individually demonstrate the lengthening or collection of strides on the flat at the walk, sitting or posting/rising trot and/or canter.
5. Figure Eight at the trot, demonstrating change of diagonals. In any Figure Eight movement, the rider should start at a center point at the halt. To finish the movement the rider is to return to the halt at the same position as the point of commencement.
6. Figure Eight at the canter demonstrating a simple lead change. The rider should start at a center point at the halt. The rider should canter a circle in the first direction, then perform a simple lead change at the center point. This is a change whereby the horse is brought back into the walk or trot (either is acceptable unless the judge specifies) and then restarted into a canter on the opposite lead. The rider is to return to the halt at the same position as the point of commencement.
7. Intentionally blank.
8. Intentionally blank.
9. Demonstrate a half-turn or a half-turn in reverse.
10. Change canter leads on a line demonstrating simple or flying changes. Unless otherwise instructed by the judge, the rider shall begin at the halt. The rider may canter on the first lead of their choice, then perform a simple change or a flying change at the center of the line. A simple change is whereby the horse is brought back into the walk or trot (either is acceptable unless the judge specifies) and then restarted into a canter on the opposite lead. A flying lead change is performed in one stride with the front and hind legs changing at the same moment. The rider shall halt at the end of the line.

11. Figure Eight at the canter demonstrating a flying lead change. The rider should start at the center point at the halt. The rider should canter a circle in the first direction, then perform a flying lead change at the center point. A flying lead change is performed in one stride with the front and hind legs changing at the same moment. The rider is to return to the halt at the same position as the point of commencement.

12. Intentionally blank,

15. Working either collectively or individually, demonstrate the canter on the counter lead. A counter canter is defined as a balanced canter on the outside lead. Riders must complete one full revolution trend the arena in each direction.

16. Intentionally blank.

17. Demonstrate a turn on the forehand done from the halt.

18. Demonstrate a turn on the haunches done from the halt or walk.

19. Demonstrate Shoulder-In, Shoulder-Out, Haunches-In, Haunches-Out, Half-pass or Leg Yield in both directions either at the walk or sitting trot.

JUMPER DIVISION

All jumper divisions are open to both horses and ponies.

Table II. Sec 1 Time First Round. The first round is decided by adding together the faults incurred over the course and any penalties for exceeding the time allowed. Horses with clean rounds or equal faults are classified according to their time taken to complete the course.

Table II. Sec 2(b)- Time First Jump-Off. The first round in first jump-off, if any, are decided by adding up together the faults incurred over the course and any penalties for exceeding the time allowed. If a competitor has gone clean in the first round, the competitor will, without leaving the ring, upon an audible signal, commence the designated jump-off course. If there are no clean rounds and a tie exists for first place, there will be one jump-off in which time will decide in the event of equality of faults.

Table II. Sec 2(c)- Time First Jump-Off (Otherwise referred to as “Power and Speed”) The first round and first jump-off, if any, are decided by adding together the faults incurred over the course and any penalties for exceeding the time allowed, if any. If a competitor has gone clean in the first round, the competitor will, upon crossing the finish line, commence the designated jump off course. Time starts as the horse crosses the finish line for the initial course. If there are not clean rounds and a tie exists for first place, there will be one jump off, in which time will decide in the event of quality of faults. The use of time allowed is optional in the first round.

SECTION VII - Points

1. **Rider points - Points will not count until all proper applications and fees are received by O.M.A.H.A.. Checks returned for any reason must be rectified (refer to Section III, article 3 and 4) within two weeks from official notification, either by show management or O.M.A.H.A., in order to receive points.** Points in all classes may only be earned by O.M.A.H.A. members currently in good financial standing with this association and with all its member shows.
2. **All entries must be made using the same members name as submitted on the official O.M.A.H.A. membership application for points to count.** If there is a change in the members name, this change must be submitted in writing to the membership/point secretary. It is the riders responsibility for using the correct name of the rider. Inconsistent use of names may result in uncredited points.
3. All show results are preliminary. Points are subject to final verification by the O.M.A.H.A. points secretary. Show results are available at OMAHA EQUINE.com. Final points will be announced at the annual meeting and party. Members may inquire about their own cumulative points, but not the points as they relate to other competitors. Any inquiries made regarding current year and awards/points must be made within two weeks of the annual meeting and awards party.
4. A class must have three entries for points for be recorded. The Show Manager may combine similar height classes. Points earned for in a combined class will her recorded in the class the rider originally entered. Diamond Equitation classes and Diamond Hunter classes are EXEMPT from this requirement.
5. COMPUTATION OF POINTS FOR ALL DIVISIONS . The computation of points for each class will be the same: 1st-10; 2nd-6; 3rd-4; 4th-2; 5th-1; 6th-1/2. These rules govern the awarding of points for the O.M.A.H.A. awards at the end of the year, not necessarily how each member show may give awards.
6. No ties between 1st and 6th place may be given in Hunter, Equitation, or Jumper classes.
7. In the event that there are 14 or more riders in any Next Step Hunter under saddle, Introduction Equitation walk/trot, Introduction Equitation walk/trot/canter, or Next Step Equitation on the flat classes, the judge may split the class into two sections. The judge shall pin each section. All points will be recorded for year-end awards.
8. In the event a (lesson) horse must enter any Next Step Hunter under saddle, Introduction Equitation walk/trot, Introduction Equitation walk/trot/canter, or Next Step Equitation on the flat classes with multiple riders, the judge may split the class into sections. The judge shall pin each section. All points will be recorded for year-end awards.
9. The O.M.A.H.A. Board will address the awarding of year end points if a show is not able to run all of the O.M.A.H.A. classes as listed in the show bill due to uncontrollable circumstances.
10. The O.M.A.H.A. Board will notify all annual award winners prior to the awards dinner.

SECTION VIII - Annual Meeting and Awards

Each year following the last O.M.A.H.A approved show, the Board will schedule an annual meeting/ awards dinner. Each member will be notified of these events.

Annual awards will be presented to Core Divisions and Classes. O.M.A.H.A. may combine divisions for year end awards at their discretion.

High Point Awards: A high point award will be awarded to the Hunter Horse, Equitation rider, and Jumper Horse with the most cumulative points in a single division.

SECTION IX - Show Manager's Check List & Responsibilities

What To Do Pre-Competition

1. Pick the date of the show and make your prize list from the OMAHA, Inc approved core classes listed in the rulebook.
2. Decide what optional division and classes you will include.
3. Hire judges (a USEF licensed judge or Industry Professional is preferred), a show secretary, an in-gate person, and an announcer.
4. If necessary, line up a farrier and a veterinarian to be on call or hire them as well.
5. Make a plan for the show grounds. You will need a show ring, warm-up ring, trailer parking, car parking (if different than trailer parking), secretary's booth, announcer location, bathroom facilities, and access to water.
6. Print out and email copies of the prize list to local barns and trainers. Posting on social media to the the word out is a good idea, too.
7. Hire a food truck or provide food options.
8. Order ribbons. Starting January 2025, show ribbons may be ordered from the O.M.A.H.A. Any ribbons not used may be returned for reimbursement.
9. Order numbers and strings for riders.
10. Plan and order prizes for class winners and champions.
11. Order or make judge's cards or tests and add/drop forms.
12. Rent or purchase walkie/talkies- the are very helpful for quick and easy communication between all show staff.
13. Get insurance. This is a must no matter how small of an event it might be.
14. Rent a Public Address (PA) system if the announcer of show grounds is not providing one.
15. Purchase secretary supplies including paper, pens, and clipboards.

16. Make copies of the prize list, add/scratch forms, entry forms, OMAHA, Inc membership forms and INHJA membership forms to have on hand.

What To Do the Day Before the Competition

1. Drag and water the rings.
2. Clean and jumps, poles or obstacles, as needed.
3. Design the courses and set up the course in the show ring.
4. Set up jumps in the warm-up ring.
5. Set up the secretary's booth. Be sure to have the judge's cards, add/scratch forms, prize lists, and entry forms ready to go. Carrot for horses and candy/sweets for exhibitors are all want a nice touch, too.
6. Set up the judge's booth with chair(s) and a table. Keep in mind that shade is always appreciated when you are picking the judges spot.
7. Put out trash cans.
8. Be sure to have extra toilet paper.
9. Set up hoses for water for the exhibitors' horses.
10. Set up chairs or stands for exhibitors to use to watch the competition.
11. Block off any areas that are off-limits to show exhibitors.

What To Do the Day of the Competition

1. Print out and/or have on-line access to the most recent version of the OMAHA, Inc. Rule Book which can be found at OmahaEquine.com.
2. Post the courses near the ring entrance.
3. Set up a clip-board for the judge. (May include the judge's cards/ tests, prize list, class count, courses or rider times, and a walkie-talkie).
4. Wipe off and chairs/ tables/ etc.

5. Station parking attendants where necessary.
6. Bring ribbons to the in-gate.
7. Pass out walkie-talkies to anyone who needs one.
8. Be available to answer questions.
9. Have fun watching the exhibitors and enjoy the day!

Post-Competition

1. Send show recognition fee, and new OMAHA, Inc. membership forms and fees, and the Horsemanship Class fees, and new Iowa Nebraska Hunter Jumper membership forms and fees to the OMAHA, Inc. Treasurer.
2. Send judges cards and Horsemanship Class results to the OMAHA points keeper.

Show Manager Responsibilities

Communicate and coordinated with officials.

Supervise and monitor show operations and delegate responsibilities as appropriate.

Follow-u on delegated tasks to ensure that all show details and jobs are done as planned.

Communicate and problems or concerns related to show facilities to the appropriate facility personnel.

Have thorough knowledge of the emergency response plan and work with emergency personnel to coordinate an emergency response.

Monitor threatening weather and make the decision to suspend and/or resume an event.

Answer any question about rule of show procedure that you feel qualified to answer. Requests for information beyond your ability to answer should be referred to the O.M.A.H.A., Inc. Board.

Resolve minor disputed that are to a formal protest that ay arise in a time and equitable manner. All disputed should be brought to the attention of an O.N.A.H.A., Inc. Board Member.

SECTION X - Officer Terms

Send The Omaha Metro Area Horse Association, Inc activities and events shall be maintain by a Board comprised of the four founding members holding the offices of President, Vice-President, Treasurer, and Secretary (and henceforth known as the Officers) and three Members-At-Large.

The Officers will hold their positions until such time as he/she decides to vacate his/her position. The remaining Officers shall invite a current active member in good standing to fill the position.

Each year, the Officer's shall invite a current active member in good standing to sit on the Boards a Member-At-Large for a term of three years. The Officers greatly value all concerns and opinions offered by the Members-At-Large. However, the final decision on all items will be made by the Officers. In the event a Member-At-Large vacates his/her position prior to the end of term, the Officers may or may not choose to fill the position for the time remaining in that term.
