In participation they expressly assume any and all risks of injury or loss and they agree to indemnify the Omaha Metro Area Horse Association, Inc. and its Board of Directors harmless from and against all claims including for any injury or loss suffered during or in connection with the competition whether or not such injury, claim or loss resulted directly or indirectly from the negligent acts or omissions of said competition, its employees and agents or the facility owners and operators. Participants in O.M.A.H.A. activities may be photographed, videotaped, audio taped or otherwise recorded and broadcast by O.M.A.H.A. staff or its agents and further agrees that photographs, videotapes, or other recordings taken by O.M.A.H.A. staff or its agents are the sole and exclusive property of O.M.A.H.A. The images may be reproduced, preserved, distributed, and used without limitation by O.M.A.H.A. for any purpose, including sale. **WARNING:** Under Nebraska law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to section 1 through 4.
